# Declaration of Personal Interests for Inclusion in the Public Register of Councillor's Interests

## ADVICE TO COUNCILLORS:

The law, and the Councillor's Code of Conduct, require you to declare Personal Interests. Some Personal Interests have to be recorded by you in the statutory public register, **within 28 days** of your election or appointment to office, and have to be updated by you **within 28 days** of any change. (There is an exemption from having to declare "sensitive information"; the Monitoring Officer can advise you about this).

This form enables you to record those interests, or to show that you have no such interests to declare.

**Please remember** that you still have to declare any relevant interests (including those in this Register) where they relate to matters under consideration at a meeting. Please refer to the Councillor's Code of Conduct for the rules on this.

**Please complete**, sign and date **either** Box A **or** Box B below, and return the form to the Monitoring Officer.
