#### ADVICE TO COUNCILLORS:

The law, and the Councillor's Code of Conduct, require you to declare Personal Interests. (There is an exemption from having to declare "sensitive information"; the Monitoring Officer can advise you about this).

**Please remember** that you still have to declare any relevant interests (including those in this Register) where they relate to matters under consideration at a meeting. Please refer to the Councillor's Code of Conduct for the rules on this.
